- Supervisory Board today approved the termination of Florian Wieser's contract by mutual agreement as of 31 December 2022 and appointed Dr Kai-Ulrich Deissner as his successor.

While we deeply regret his decision, we also respect his request for a change for personal reasons. **Düsseldorf, 22 September 2022** – Florian Wieser (40), member of the Management Board and Chief Financial Officer (CFO) of CECONOMY AG since May 2021 as well as CFO of Media-Saturn-Holding GmbH since November 2018, has decided to leave the Group and seek new professional challenges. The Supervisory Board of CECONOMY AG has approved the mutual termination of Florian Wieser's contract as of 31 December 2022 and already found a successor: Dr Kai-Ulrich Deissner (53), currently CFO of the Technology & Innovation segment at Deutsche Telekom AG, has been appointed as the new CFO of CECONOMY AG and is expected to start his position on 1 February 2023. In a dual role, he will also serve as CFO of Media-Saturn-Holding GmbH.

Dr Kai-Ulrich Deissner has worked for Deutsche Telekom in various CFO roles for more than 10 years. During this time, for example, he was CFO of Hrvatski Telekom, the third-largest listed company in Croatia, where he played a decisive role in the company’s successful turnaround. Previously, Deissner was CFO of the service and call centre business in Germany. Most recently, as CFO Technology & Innovation, he helped to successfully transform the Group’s technology and innovation portfolio in Europe. Before joining Deutsche Telekom, where Deissner initially worked in marketing, sales and service, he held various roles in consulting & the media industry.
